- 2. The Planning Board voted unanimously last night to remove article #32

Bob Snow made a motion to remove article #32, Joe Perry second, all in favor - aye (4-0).

Bob Snow made a motion to close the Special Town Meeting Warrant, Joe Perry second, all in favor - aye (4-0).

Joe Perry made a motion to sign the Special Town Meeting warrant, Bob Snow second, all in favor - aye (4-0).

The Board signed 8 copies of the signatory page.

Pierce commended the Town Administrator and Assistant Town Administrator for putting the warrants together in a professional manner.
