1. Discuss and approve the preferred schematic submittal to the Massachusetts School Building Authority for the Pine Grove School Feasibility Study

Chairman Snow read the draft letter to Diane Sullivan into the record. Eagan said on December 19th, the options were presented to the Board of Selectmen, and the Board formal vote is needed today. She said the School Building Committee recommends Option B. She said the Board needs to vote to authorize Bob Snow to sign the letter. Merry said he suggests that we do Option B, but to look for cost savings within it. Pierce said by approving this, we are not locking ourselves into anything. Jon Richardson of Dore & Whittier agreed and said the major difference between the options is the HVAC system. Pierce said site work has also been proposed for a cost of \$2.4 million on top of the \$35 million for the renovation. He said it will be a high number even with some cost savings, and Joe Perry is focused on that. Snow said he agrees with his colleagues that Option B is the best option, but we should keep a close eye on the budget and try to reduce the cost. He said Rowley is a very frugal town, and the new public safety buildings are not the Taj Mahal, but are functional buildings.

Bob Merry made a motion to approve Option B, Cliff Pierce second, all in favor - aye (3-0). Joseph Perry - ABSENT David Petersen - ABSENT
