2. Designate the positions of dispatcher and reserve dispatcher as Special Municipal Employees pursuant to Massachusetts General Laws Chapter 268A

Chairman Pierce read the following:

We have a reserve dispatcher who was recently appointed by the Board of Library Trustees to the position of Librarian.

Under the State Ethics Law disclosures need to be filed for special municipal employee status positions when an employee is appointed to "multiple contracts."

The position of Librarian was designated many years ago as a "special municipal employee." The position of dispatcher has not been designated.

The Board needs to vote to designate the positions of reserve dispatcher and dispatcher (full-time) as "special municipal employees."

Once that is done, the employee will be able to file the multiple contracts disclosure forms.

Joe Perry made a motion to designate the positions of reserve dispatcher and dispatcher (full-time) as special municipal employees, Dave Petersen seconded, all in favor – aye (4-0). Deana Ziev - ABSENT
