CALL MEETING TO ORDER

Chairman Robert Merry called the meeting to order at 7:00 p.m. He said the meeting is being audio and video recorded digitally.

2. <u>Discuss donation from Yankee Pine Corporation to pay for Town Hall elevator upgrade</u>

Chairman Merry read the following:

The Yankee Pine Corporation is donating the funds to upgrade the Town Hall elevator. The company has submitted a check made payable to Halley Elevator Company, Inc. in the amount of \$1,965.00, which is the amount we put in the special town meeting warrant.

The Board of Selectmen needs to vote to accept this donation and to send a letter thanking Yankee Pine Corporation for this generous donation.

Dave Petersen made a motion to accept this donation and to send a hardy note of thanks for this very much appreciated donation, Jack Cook second, all in favor - aye (5-0).

NEW BUSINESS

1. One-day liquor license application from Clark School

Chairman Merry read the following:

Tammy O'Brien Donohue will be present this evening.

Clark School, 14 Forest Ridge Drive, Rowley is requesting a one-day liquor license for Friday, November 14, 2014 from 6:00 p.m. to 8:30 p.m. for a Parent Advisory Committee fundraiser and parent social event. Only wine will be served and there is a two-glass maximum per person. No one under the age of 21 will be allowed to attend.

Chief Barker has signed off on this application with the following conditions:

"Since there is no TIPS certified bartender, I would require strict adherence to a two drink per person limit." Chief Robert Barker, 10/20/2014'

If the Board of Selectmen approves this application, Chief Barker's conditions can be stipulated in the approval and written on to the license.

Additionally, the applicant is required to purchase the wine from the ABCC approved distributor list.

Petersen asked Donohue if they can abide by these conditions. Donohue said yes. Petersen said it is a nice looking school and welcomed them to the Town and wished them good luck. Merry said the application appears to be in order (COPY ATTACHED).

Jack Cook made a motion to approve the one-day liquor license application from the Clark School, Joseph Perry second, all in favor - aye (5-0).

2. <u>Discuss 44 West Ox Pasture Lane</u>

Petersen said he attended a meeting about ten days ago organized by Town Planner Kirk Baker. He said representatives of the Fire Department, Board of Health and Conservation Commission were also at the meeting. He said a developer wants to put houses on the 44 acres of land and reviewed the map of the property (COPY ATTACHED). He said right now there is a combination of commercial and residential land, and they want to develop part of the 44 acres. He said they will be submitting plans to the Planning Board and said the development would be entered from West Ox Pasture Drive and there is a right of way abutting Arthur Gordon Drive. He said they are looking to develop 18 to 20 houses maximum and are presenting the general concept and looking for feedback before the plans are designed. He said his biggest concern is

that West Ox Pasture is an unpaved road that is complicated and expensive to fix. He said he asked the developer to address this. Merry said only 900 feet of West Ox Pasture Road has been accepted by the Town. Petersen said there are many issues to be addressed, and he wanted to update the Board about this potential development that may start in the next year or so.
