Below is our response the letter from Larry Graham of Graham Associated dated November 1, 2022 in reference to the Site Walk on October 31, 2022.

1. The crushed stone at the driveway entrance from Wethersfield Street, right side, is still high forcing runoff to the edge of Wethersfield Street versus the design of directing it to the roadside swale This condition should be corrected.

Response: The crushed stone has been partially re-worked but will need minor additional adjustments in the Spring when weather allows.

- 2. In general, the site conditions as relates to ground cover, vegetation and stabilization are much improved from my last site visit. Further I would suggest that the site vegetation and stabilization are acceptable with the following noted minor exceptions:
 - The side slope and top of slope areas generally between Sta. 2+0± and 3+0±, right side shows areas of little to no vegetation.

Response: This area will re-worked in the Spring when weather allows.

 A very small area generally near Sta. 5+25±, left side shows an area of little to no vegetation.

Response: This area will re-worked in the Spring when weather allows.

 A few areas of the site showed grasses which Mike Seakamp suggested may be annuals. A revisit next spring or early summer to be sure this vegetation returns is recommended.
