ARTICLE 15. Move the Town vote, pursuant to Mass. Gen. Laws Ch. 44B, to transfer and appropriate from the Community Preservation Fund Historic Resources Reserve and/or the Community Preservation Unreserved Account the amount of \$12,000 to be used by the First Congregational Church of Rowley for costs associated with preservation, restoration and digitalization of the journal known as the Philips Diary, or take any other action relative thereto.

Explanatory Note: The Community Preservation Committee has approved this article. Reverend Samuel Philips was assistant and successor to Rowley's founder and first minister, Rev. Ezekiel Rogers. This diary/journal begins on or about 1660 and is considered to be one of the earliest

records in our town's history as any and all records maintained by Rev. Rogers were destroyed by fire in 1660. The diary/journal consists of approximately 542 pages and, as far as can be determined, contains both church and town records since at this point in time there was no clearly defined separation between the entity that existed as a church and the municipality. It has been suggested that although it is not known precisely what is contained within the pages of this document, due to its present fragile state, this may well be one of the nation's earliest records of precolonial America, perhaps documenting the seeds of democracy in the new world. The \$12,000 request retects an estimate from The North East Document Conservation Center to stabilize, restore and digitize the Diary/Journal. Upon completion of this project, digitized copies would be made available to The Rowley Public Library, the Town Clerk's Office, etc. to allow public access for research purposes.

Statement to Town Meeting: There is a misprint in Article 16. The article as printed in the January 11, 2010 Special Town Meeting Warrant says "Section 16'. It should read "Section 4'.

The motion is worded correctly.

ARTICLE 16: Move the Town will vote to amend section 4 of the Historic District Bylaw by adding to such section the words and punctuation marks that appear in **bold** within parentheses, as shown below:

Section 4. There is hereby established under the provisions of Chapter 40C of the General Laws an Historic District Commission, to have all the statutory powers and duties of an historic district commission thereunder, consisting of seven members to be appointed by the Board of Selectmen in accordance with the provisions of the statute. The initial appointments to membership in the Commission shall be as follows: two members appointed for a term of one (1) year; two members appointed for a term of two (2) years; and three members appointed for a term of three (3) years. Vacancies shall be filled in the same manner as the original appointment of the unexpired term. (The Board of Selectmen may appoint three residents of the Town to serve as alternate members of the Historic District Commission for a three-year term. The Chairperson of the Historic District Commission may appoint an alternate member to act on applications, in the case of absence, inability to act, or contict of interest, on the part of a regular member of the Historic District Commission, or in the event of a vacancy on the Commission.)

Explanatory Note: The Board of Selectmen seeks an amendment to the Historic District Bylaw at the request of the Historic District Commission. Motion by Richard Cummings, seconded by Robert Snow, passed voice unanimous at 9:03 pm
