The Applicant, Mr. Ed Juralewicz of United Sign Co. (representing the builder, John Coughlin of Gateway Trust II), stands before the Board, introduces himself and begins explaining the intent and the size (3'x10') of the two (2) proposed signs. He explains the size of a sign per the bylaws will be quite difficult for patients to read given the distance from the entrance to the appropriate doctors building (approx. 150') hence the need to get approval from the Zoning Board for larger (3'x10') size signs. Says it's simply a case of properly identifying the space.
